The Giri Van Award for Best Clinical Case Study/ Short Communication

The Awards are supported by Dr R. G Jani. Former Professor (Veterinary Medicine) & Coordinator Indian Wildlife Health Cooperative (Western Region), Anand Veterinary College, Gujarat in honour of his parents Smt Vanita and Shri Girijashanker Jani. The awards aim to recognize individuals whose work advances knowledge, practices, and innovation in Indian wildlife management, conservation, and veterinary care.

The VanGiri Award for Best Research/Review article on Wildlife Health and Management is to be presented to an author whose article demonstrates excellence in research, analysis, and communication. Articles eligible for this award must demonstrate originality, depth, and clarity while addressing key challenges or breakthroughs in wildlife conservation. They must provide insights that can guide policy, management, or community participation in preserving India's rich biodiversity.

The *GiriVan* Award for **Best Clinical Case Study/ Short Communication** is to be awarded to veterinarians and wildlife health professionals who document unique clinical cases or provide short communication on any aspects of wildlife health and management in captive or free ranging wildlife. It recognizes case studies that combine scientific rigor, innovative methods, and compassion for animals. Entries in this category will highlight rare or challenging clinical cases, offering lessons that inspire advancements in wildlife veterinary practices.

Submissions will be evaluated by an expert panel. The panel will assess articles and case studies based on originality, impact, scientific accuracy, and the potential to influence wildlife conservation or veterinary practices.

Winners will be presented with a certificate and a medal or memento.

Both awards symbolize a step forward in encouraging researchers and field practitioners to contribute meaningfully to the field.



General Guidelines

- The candidate should be a life member of AIZWV
- 2. Proof of age should be enclosed with application.
- 3. The candidate(s) fulfilling the above criteria shall apply for the award to the General Secretary in the prescribed format available on the AlZWV website (www.aizwv.org) on or before the last date of submission as per the brochure of the 15th Annual Convention of the Association of Indian Zoo & Wildlife Veterinarian & International Zoo and Wildlife Health Conference.
- 4. Applicant for the Memorial/ Appreciation/ Achievement Awards may self-nominate or an AIZWV Life member can propose a nomination. Recommendations of the proponents who are eminent professionals preferably working in the thrust areas of the said award may be included.

Judging Criteria

- An evaluation committee consisting of three senior, eminent AIZWV life members shall be appointed to screen and evaluate the application(s) based on detailed information provided as per application format. The General Secretary of the Association shall be Ex-Officio member and shall act as member secretary of the committee. (None of the members evaluating the "Best Young Researcher" would be from same Institution/ College/University)
- 2. The majority decision of the selection committee shall be final. In the absence of a clear majority, the final verdict shall be with the President of the AIZWV.
- 3. In case if number of applications is less than three, the case would be judged on its merit and decision taken by the evaluation committee.
- 4. It is a one-time award for the applicant and the same applicant will not be reconsidered for the same award. A maximum of one Award for Excellence is to be bestowed in this category at a time.
